LA INTERVENCIÓN CON VÍCTIMAS DE EXPLOTACIÓN SEXUAL

Resumen/Abstract:

Los niños, niñas y adolescentes víctimas de explotación sexual presentan unas características y necesidades particularmente complejas que las diferencian de otras víctimas de violencia sexual. La polivictimización, las experiencias vitales adversas y el trauma complejo son características frecuentes. La ponencia presentará las conclusiones de una revisión bibliográfica sobre la intervención con estos niños, niñas y adolescentes desde la perspectiva de los servicios de protección a la infancia y adolescencia: consideraciones generales para el abordaje del problema; tipos de servicios y programas diseñados para su atención, objetivos y resultados; profesionales intervenientes; y particularidades de la intervención desde los centros de acogimiento residencial.
